Temporary Winter Market Vendor:* Temporary Winter Market Vendors will be voted in for a single winter market season and be awarded no voting rights with the PFMA, and will be held to all fees and rules as regular PFMA members. Applications for Temporary Winter Market Vendors (separate application form) are due September 5th. The Temporary Winter Market Vendor Meeting will be held annually on the 2nd Saturday in September and will need 2/3rds majority vote to be accepted. Temporary Winter Market Vendor dues and [approximately] half winter market rent (equaling total rent deposit of \$400) are due at time of acceptance.

**Fees Due Upon Acceptance:** \$100 City License, \$200 Membership Fee, \$50 Winter Dues, Rent Deposit \$400/booth
